10.01.08 PAVEMENT ON WYCHE LANE

Two emails have been received from a resident of Wyche Lane with this suggestion and some information on users of the route. These were circulated to Members before the meeting. The benefits of a footpath were discussed. It was noted that agreement would need to come from Highways and there were regulations which specify a minimum width of 1.4 metres. It was thought that a feasibility study had previously been undertaken, the outcome of which was not positive. The Clerk to ask Highways to look at the feasibility from a planning view.

10.01.09.1 Converting old playground to car park - An update

General update –Guiness (formerly Wulvern) and Strutt and Parker, the developers who are considering the request for a funding contribution, are expected to reply by Spring. There is still no response from the other developers so a further request will be sent to them. **Relocation of benches**- deferred.

10.01.13 PARISH COUNCILLORS' REPORTS

Cllr. Parker reported that a resident in Wyche Lane is celebrating a 100 birthday. The Clerk will send a card from the PC.

Cllr. Pulford was contacted by the So Cheshire website with a request for a comment from Bunbury Parish Council regarding the current campaign for Beeston and Tarporley Railway Station to be re-opened.

Cllr Pulford asked if Members felt that there is support for the initiative from the local community. A majority of Members were in favour in principle of the station reopening on environmental grounds. It was noted there were other factors that would have to be considered if the station were to be reopened.

Cllr Griffiths will report the continuing problem of construction traffic using Long Lane to Highways.

Cllr Potter wanted to congratulate Ted Fowles who was awarded a British Empire Medal in the New Year Honours. Cllr Potter is donating a bench to the community and has suggested siting it on the playing fields, so will seek permission from the playing fields committee. Cllr Potter proposed a vote of thanks to the Chairman and the Clerk for their excellent performance of their duties over the past 12 months.

10.01.15.01 Purchase of grounds maintenance equipment for the Bowling Green

Details of the specification and quotes had been circulated before the meeting. The equipment will cost £7000 in total. The Bowling Club has fundraised £5000.

10.01.15.03 Setting the precept for 2018/19

The Parish Council completed the process of setting the precept to be requested for 2018/19 Cheshire East Council fixed its Taxbase for the financial year 2018/19 by Resolution of the Council on the 14th December 2017. The Taxbase for Bunbury Parish Council area is 632.34 compared to a current amount of 633.54.

As an indication, if the current Band D Council Tax (of £31.57 per annum) remained the same, this would reduce the precept from £20,000 to £19,962. Alternatively, if the precept remained at £20,000 then the Band D Council Tax would increase to £31.63 when using the new taxbase. If the precept is increased by 5% to £21,000, the Band D Council Tax would increase by £1.58 per annum.

RESOLVED: to set the precept at £21,000.
